I understand that personal cheques will not be accepted.

I/We acknowledge, if my bid is successful, that I/we will deliver to the Quota Exchange Administrator, not less than 10 days before the first Wednesday of the effective month, by direct deposit or by certified cheque, an amount equal to the balance of the total amount required for the purchase of Quota.

I/We acknowledge that if my bid is successful and I opt not to proceed with the transfer after the exchange is run, the 10% deposit is forfeit.

I/We acknowledge that in the event the cumulative volume of quota units bid is less than the 75% of the cumulative volume of quota units offered, the Quota Exchange Administrator may cancel the Exchange.

I/We acknowledge that in the event the cumulative volume of quota units offered is less than the 75% of the cumulative volume of quota units bid, the Quota Exchange Administrator may cancel the Exchange.

**Bid to Receive Quota (cont'd)**

Unless otherwise specified, I/we acknowledge that in the event the cumulative volume of quota units bid is equal to 75% or more of the cumulative volume of quota units offered, the Quota Exchange Administrator may deem me to have bid a percentage of the quota units set out in this bid, based on the ratio of quota units offered to the quota units bid.
