

**NOTIFICATION OF SUCCESSFUL EXCHANGE**

December 7, 2016

- 19,964 laying hens (Lower Mainland quota units)
  - 108,862 quota units were requested for purchase by 18 producers
- 2,421 laying hens (Interior quota units)
  - 2,421 quota units were requested for purchase by 1 producer
- 4,996 laying hens (Vancouver Island quota units)
  - No offers were requested for purchase; per Schedule 8 rule 1. (8) this quota was placed and sold to Lower Mainland purchasers as it had the lowest offer to buy fill rate.

The quota units were distributed as per the procedures found in [Schedule 8](#) of the Consolidated Orders.

The offer to buy fill rate was 25%, the price per unit on the March 1, 2017 exchange will be \$355.00.
