CALL TO ORDER

Chair, Gunta Vitins, called the meeting to order at 9:59 am.

CONFLICT OF INTEREST

1.0 Updates from BOD Meeting

1.1 EFC Update

EFC will be sending out Market Updates on a weekly basis to the provincial boards that will include updates on the changing market needs. An update was provided on egg storage, charitable egg donations, the IP market and the COP pricing discussion.

1.2 EFP Update

BC Egg received notice from EFC that as of week 15 the processor will no longer be accepting BC Egg's EFP production. The Board discussed finding alternative markets for the EFP production.

1.2a Charity and Food Banks

Staff provided an update to the Board that the foodbanks are willing to accept any amount of egg donations that can be given. Staff has contacted the grading stations to confirm their interest in supporting this initiative.

R20-054 It was MOVED by Walter Siemens and SECONDED

THAT the Board direct staff to move 350 boxes of EFP off sizes to donation and charity programs.

CARRIED.

Action: Staff was directed to communicate BC Egg's plan with EFC.

The Board also discussed the interest expressed by producers for a charity drive. The Board will review further as more information is made available.

1.3 Atlantic Region- Letter on Pricing

The Chair sent a response to EFC on behalf of BC Egg reiterating support for the national coordination of pricing as well as the collective decision to hold pricing during the early months of COVID19 challenges.

1.4 PFGC Update

An update was provided to the Board on the status of the post farm gate cost (PFGC) analysis that is ongoing with JRG Group. JRG has indicated that interviews with provinces and graders were going well but that some participants required further clarification on the project parameters etc. Written responses to the participants were reviewed and finalized,

A meeting will be scheduled on May 4th with JRG, BC Egg and Egg Farmers of Alberta to discuss preliminary findings of the analysis and steps moving forward.

1.5 Product Update

An update on a producers appeal was presented to the Board. The appellant sent in their final response to BC Egg's defense and it is now with BCFIRB for review and decision. BCFIRB Is expected to provide a decision on the appeal within the next 30 days.

2.0 COVID-19 Update

2.1 Fowl Removal

Due to a change in market demand, the processor who removes spent hens has requested that some of the spent fowl move to rendering instead of processing. This will mean an added expense for BC's egg producers. Staff arranged for removal of the spent hens for rendering.

2.2 <u>EFC EFR Program</u>

EFC has requested that the provinces provide them with information on flocks that could be removed early to reduce the burden on the IP program. Staff will continue to keep EFC informed of any flocks that meet EFC's eligibility requirements.

2.2 Economic Impact Study

Serecon will be providing a quote to the 4 feather boards on an economic impact study that will quantify costs the industries have incurred due to COVID-19. The data is intended to be used to identify and recover costs through government funding programs such as Agri Stability or

3.1 FOI Request
