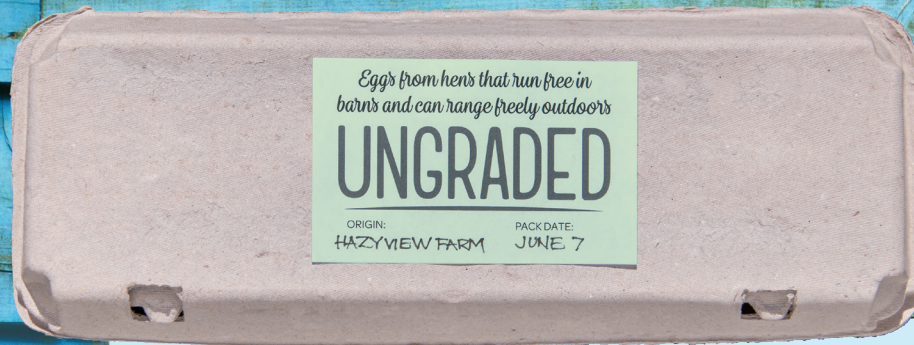
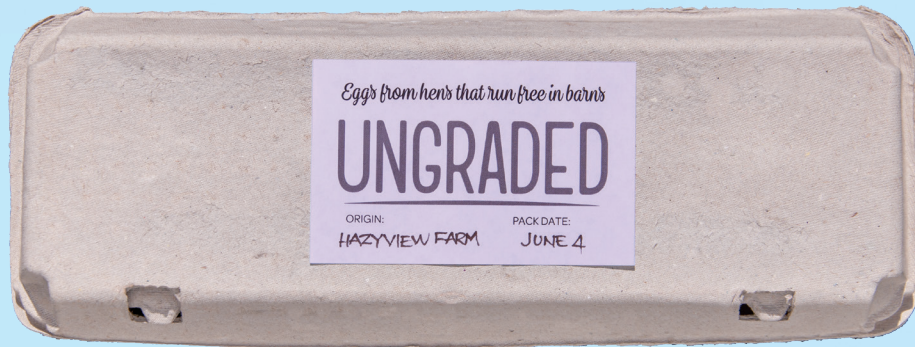


The Small Lot PROGRAM



The Small Lot PROGRAM

The Small Lot Program is for unregistered producers who keep between 100 and 399 laying hens that produce organic eggs, heritage-breed eggs, free-range eggs or free-run eggs. Small Lot Producers are required to follow standards for food safety and biosecurity as described in the *BC Egg Small Lot Producer Guidelines*.

Producers may sell ungraded eggs directly to end users (those who will actually be eating the eggs). These sales can be made through farm gate sales at producers' premises or at farmers markets. Ungraded eggs must meet the following requirements:

1. The eggs must be produced on the producer's own farm.
2. The eggs must be clean without any visible cracks or leaks.
3. The eggs must be kept at 4 degrees Celsius until they leave the producer's possession.
4. The eggs must be packed in clean cartons that are marked as "Ungraded" in letters at least two centimetres high.
5. The cartons should also include the name of the farm/producer and the packaging date.

Small Lot Producers are not permitted to sell eggs to food retail establishments or food service operations. Food retail establishments include grocery stores, convenience stores and other retailers that sell food and beverages directly to consumers. Food service operations include businesses and non-profit organizations such as restaurants, institutions, hotels and caterers that provide food and beverage services directly to consumers. Small Lot Producers cannot sell eggs to a Registered Shell Egg Station.

The Small Lot Producer application fee is \$250 with an annual renewal fee of \$250.
